6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM onwards on 5th April 2020 A.D (23rd Chaitra 2076 B.S). at the office of Bhimad Municipality. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs as mentioned in table below which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days after bid opening).
