Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **NRs. as mentioned in table below** , which shall be valid for 30 days beyond the validity period of the bid.
